2. It is a privilege to inform you that your application has been considered and accepted for provisional approval as New Sainik School under the aegis of Sainik School Society (SSS), Ministry of Defence (MoD) **subject to signing of Memorandum of Agreement (MoA) with Annexures therein.** Copies of Policy Document including Qualifying Requirements (QR), Rules and Regulations for New Sainik Schools in Partnership Mode(R&R), Memorandum of Agreement (MoA) with SSS and Academic Plus curriculum are shared on your registered email ID.
3. **It is requested to peruse the contents of this letter and all other enclosures/ shared documents carefully and understand the terms and conditions of the provisional approval.**
4. **It is requested to deposit the annual approval fees of Rs 25,000/- to Sainik Schools Society online at <https://sainikschool.ncog.gov.in/>. Memorandum of Agreement along with Annexures duly signed by Appropriate Competent Authority should reach to Inspecting Officer, at Sainik School Society, Room No. 101, D Wing, Sena Bhawan, New Delhi- 110011 on or before 31 Mar 22.** Scanned copies of signed MoA along with Annexures, Proof of payment of annual approval fee and Proof of dispatch of signed documents be emailed to Sainik School Society at newsainikschools@gmail.com.
5. The school has been provisionally approved for a period of two years where after the school would be considered for accord of Regular Approval for specified duration from the date of approval based on performance reviews during the provisional approval period. However, the SSS reserves all rights to cancel the Approval at any time if a school fails to meet the stipulations laid down in the MoA and R&R.
6. Provisional approval as New Sainik School will be effective from the date of signing of MoA between the School and SSS. Indicative timeline of all activities required to be carried out before commencement of academic session 2022-23 is enclosed. The Academic Session should commence positively by 30 Apr 2022.

7. Admission in the approved Sainik Schools will need to be carried out as per prescribed regulations in R&R. Every year, fresh admission of students in Sainik School pattern will be conducted for class VI only. The details of Admission process may be seen at Chapter 7 of R&R.
8. A qualifying test for admission of the students enrolled in your school and willing to study in Sainik School pattern from class VI onwards will be conducted by an Agency identified by SSS. It may be ensured that in order to start your academic session in 2022-23, registration of willing students for taking such qualifying test is completed as per timeline enclosed.
9. New Sainik Schools can have two separate verticals in the same school, one for the students under the Sainik School model from class 6 onwards and the other out of it. If the school chooses to maintain two verticals- namely Sainik School portion and non-Sainik School portion, the classes and activities for both will need to be held separately.
10. Standard common uniform for the students opting for and studying in Sainik School System will be prescribed by SSS. It may be ensured that such students mandatorily wear the common standard uniform for parity across all New Sainik Schools. The option of prescribing the same Uniform for those students also who are not opting for Sainik School pattern within the same school lies with the school.
11. The school shall include Special Subjects into its curriculum and ensure to conduct related activities as mandated by the SSS to provide physical and health education, life skills education, digital education, experiential learning and value education with particular emphasis on National ethos Details of Curriculum may be seen at .Appendix 'E' of the R&R.



Shriman,

Under Section -18 of the right of children to free and compulsory education, Act- 2009 and Rule (5) (1) of the right of the children to free and compulsory education Act-2012 under received powers and under Mumbai Primary Education Rules-1949, from June-2023 new non-aided lower primary private primary school to start from your school board received online application and attachments attached to the application and based on that from June- 2023 non- aided new lower primary (Std. 1 to 5) / upper lower primary (Std. 6 to 8) school to start permission is given as per following conditions.

The Medium of instruction in your school will be English and from June- 23 will be able to run one of each, class std. 6 to 8.

CONDITION :--

- (1) School board shall be responsible for fulfilling and maintaining the conditions of the school
- (2) It shall be the responsibility of the school to comply with all the provisions of the right of children to free and compulsory education Act- 2009 and the right of children to free and compulsory education Rules- 2012 and the Gujarat Primary Education Act- 1947 and Mumbai Primary Education Act-1949.

- (3) In addition to the Act and the rules framed thereunder, it shall be the responsibility of the school to comply with the rules, regulation, resolution, circulars, instruction etc. promulgated by the state Government from time to time.
- (4) The School should admit 25 % of the number of the students in Class- 1 including pre-primary classes to the children of weaker sections and disadvantaged group of the nearby area and should provide free and compulsory elementary education till its completion. And for its implementation, the concerned office has to be contacted.
- (5) Fee taking by capitation is prohibited and therefore the trust or the school shall not accept any capitation fee or otherwise other donations or items in lieu of such fees.
- (6) Any screening test or a child or his or her parents or guardians for purposes of school admission or any procedure should not adopted in any practical manner.
- (7) A school shall not refuse admission to any child on the ground of lack of proof of age or religion caste creed or caste place of birth or any of these grounds.
- (8) What should the school determine :
 - 1] No admitted child shall be held back in any class other than class 5 and class 8 till the completion of elementary education in the school or not to be dismissed from the school or be processed under existing rules of class promotion.

- 2] No child shall be subject to physical torture or mental torture.
 - 3] Every child who completes elementary education shall be awarded a certificate as prescribed under rule- 30.
 - 4] As per the provisions of the Acts, special needed students with disabilities have to admitted.
 - 5] Teachers with educational qualification as prescribed by the government from time to time have to be recruited.
 - 6] Teachers student ratio should be as per rule. The classroom area in the school should be as per rules and should have all necessary physical facilities.
 - 7] A teacher shall perform his duties a specific under Sub-section (1) of Section -24 of the Act.
 - 8] Teachers themselves cannot provide private tuition, it will be the responsibility of school board to see it.
 - 9] A transparent and fair admission process shall be followed by following guide lines and orders issued by the Central Government or the State Government or Director.
- (9) The school has to provide education as per the syllabus prepared on the basis of the syllabus formulated by notified authority.
 - (10) The School should admit students in proportion to the facilities available in the school as stipulated in Section--19 of the act.
 - (11) The School should maintain the school norms and standards as directed in Section- 19 of the Act and all the conditions of Rule--13 information relating to maintenance of school website and timely

filling of true and faithful DISE (Dias) District Information System for Education data (information) should be complied with.

- (12) No un-authorized classes should be conducted inside the school / premises or outside the School under the same name.
- (13) The school building or other structure or grounds shall be used only for the purpose teaching skill development.
- (14) School societies Registration Act- 1860, and must be carried on by a Society Registered under- 21 of 1860 and 1952 or by a society in incorporated under the laws in force at the time.
- (15) The School shall not be run for the profit of any group or association of persons or any other persons.
- (16) Accounts should be audited and certified by a Chartered Accountant. And proper books of account should be prepared as per rules. Every year a copy of the audited statement of accounts should be sent to the competent authority.
- (17) The facility with recording of CCTV Camera should be available and the competent authority should be assured for the same.
- (18) Necessary measures for school safety have to be taken within the time limit as per the guidelines of the National Disaster Management Authority. School safety Policy- 2016 has to be implemented.
- (19) The certificate has to be renewed from time to time with the competent authority regarding the facility of fire safety in the school.

- (20) The safety of students and staff must be ensured by taking such measures as may be necessary for their safety.
- (21) The School Board cannot insist or compel the students to buy certain types of book, literatures, uniforms or boots, from their institutions, from a particular institution or agency or from particular brands or companies.
- (22) The provisions of the Gujarat Self dependent Schools Act, 2017 and the rules made thereunder will be applicable this school and a compliance form will have to be submitted.
- (23) The competent authority Mr. or a person authorised by him and the inspecting officers the education department shall be allowed to inspect the school.
- (24) The school has to use only the approved syllabus and textbooks approved by the Government.
- (25) Education fee's rates and pay scale of academic and non- academic employees should be approved by the Government.
- (26) The records, statistics or forms and certificates provided by the principal or administrators of the school should be reliable.
- (27) The director of the school and competent authority shall furnish report and information from time to time and comply with such orders as may be given by the state Government to the local authority to full fill the condition of accreditation for the continuation of the school or to remedy deficiencies in the functioning of the school.

- (28) No change in the name of the school, change in the location of the school or change in the system of the school can be made without the prior permission of the competent authority.
- (29) The school has to be started in the same year in which the school is sectioned if the school is not started within six months after the approval, the approval will be automatically cancelled.
- (30) School building for public examination and public interest when required, the school administrator will have to make spare and give it for use.
- (31) All the resolutions / circulars/ instructions, issued by the government should be followed.
- (32) The revenue and other grounds furnished by the above approval are deemed to be correct, in future, if found to be fake any basis, the governing body will be held responsible and the Government will be empowered to take action against them, including police complaint. And note that.




